1. Introduction to UHC



Our healthcare system is well developed, but faces some challenges





Bermuda's health care system faces many challenges, not least high costs and unequal access to care.



Strengthening our health system is multi-year journey towards delivering Universal Health Coverage for essential services and a long-standing ambition for Bermuda. It is also a global direction of travel for many countries, including island jurisdictions.



Bermuda is fortunate to already have a well-developed health system with many strengths, yet our health outcomes are not as good as we would expect them to be considering the high expense.



Residents require access to affordable and essential health services which are delivered effectively and efficiently, and where the health results are measured, monitored and improved.



While we are guided by international best-practice, we are Bermuda-centric in approach, and will be adopting and adapting in a way that works best for our island and people.


Bermuda's Health Strategy contains initiatives to face these challenges



Winter 2022

New Bermuda National Health Strategy 2022-2027 published

Work on key initiatives, including:

- Joint Strategic Needs Assessment.
- National Digital Health Strategy.
- National Health System Metrics.
- Assessment of Merger of Government Funds.

Spring 2021: Phase 1

UHC Steering Group convenes. Initial discussions towards developing an approach for health system strengthening

Winter 2021/22

Presentation of roadmap to wide range of stakeholder

Spring 2022

UHC Steering Committee expanded and establishes regular monthly meetings to undertake foundational work for 2022/2023.

Presently: Finishing up Phase 2 and starting work on Phase 3

UHC Steering Committee confirmed upcoming initiatives to continue work on UHC, to start early 2024.



2. Update on finalised initiatives



STRATEGY

UHC remains largely on track, reporting the following progress in past initiatives

#	Initiative	Status
1	Merger of Government Funds	This project has been completed.
2	National Digital Health Strategy	This project has been completed. The final report due to be publicly released on Friday, 8 December 2023.
3	Joint Strategic Needs Assessment	The project is completed, and the full document can be found on healthstrategy.bm.
4	National Health System Metrics	This project has been completed.
5	National Procurement Assessment	The project is nearly complete, with the report finished and pending final approval.
6	Integrated Care Pathway – First 1,000 Days	The project is nearly complete, with the report finished and pending final approval. Costing to be updated in next phase.
7	Integrated Care Pathway – Chronic Kidney Disease	The project is nearly complete, with the report finished and pending final approval. Costing to be updated in next phase.
8	Integrated Care Pathway – Mental Health	This project has been completed.



Purpose:

- Bermuda JSNA 2023 assessed health needs comprehensively
- Considered social determinants of health and healthcare services
- Provides 24 recommendations for stakeholders' consideration and action
- Prioritises actions for significant impact on health
- Integral to Bermuda Health Strategy 2022-2027 and UHC programme
- Supported by international benchmarking and metric development

Scope:

- Population profile and wider social determinants of health
- Health behaviour and risk factors
- Causes of illness and death
- Vulnerable groups
- Healthcare services

Key results:

- Leading causes of death in Bermuda: non-communicable diseases, especially circulatory disease (heart attacks, strokes) and cancer.
- 90% of Bermuda residents experienced at least one type of adverse childhood experience; up to 694 domestic incidents between adults in 2022 (domestic violence is underreported).
- In 2018, Bermuda spent \$11,529 per capita on healthcare, the highest globally.
- Healthcare shift needed for Bermuda's aging population, moving from a fragmented to a coherent system.
- Significant gaps in health information; further work required for linked information in the health and social care sector.
- JSNA development started in September 2022, with a launch event in November 2022 and publication in September 2023.

Key milestone: completion of National Digital Health Strategy, now planning its implementation



Vision:

A sustainable and digitally integrated health ecosystem designed to meet the diverse and often divergent needs of the community and health professionals, improve quality and safety and drive better health for all.

Methodology:

Together with health system stakeholders, developed a National Digital Health Strategy that is aligned with Bermuda's health strategy, helps to enable those strategic principles, and provides a North Star document to guide development and prioritisation for implementing a digital health strategy for Bermuda.

Results to date:

- Strategy complete, to be introduce to the community on 8 December 2023
- Implementation planning phase began in October 2023

National Digital Health Implementation (goals through end of March 2024):

- Define technical requirements for a digital health platform infrastructure to inform where/how a digital health platform could be housed
- Develop a National Digital Health implementation plan (governance structure, workforce planning, budget, timeline)



3. Communications Strategy



Progress, findings, and recommendations on UHC initiatives will be communicated to all stakeholders through the **Communications Strategy**

A communications and engagement strategy has been developed incorporating five key strategic principles:

- **1. INFORM** Stakeholders are aware of UHC initiatives, progress, outcomes and next steps.
- 2. EDUCATE Stakeholders understand the information they are receiving and their role in health system. transformation.
- 3. CONSULT & ENGAGE Stakeholders have the opportunity to share insights and feedback and have an active role in developing solutions, strategies and implementation plans.
- 4. COLLABORATE Stakeholders can effectively work together to navigate and effect the implementation plans.
- **5. EMPOWER** Stakeholders are empowered to be involved, use their voices, and make personal and professional choices that support a healthier lifestyle and sustainable health system for Bermuda.



4. Future Initiatives



Over the coming months, we will be launching eight new initiatives.

#	Initiative	High-level description of initiative
1	Healthcare Modelling	Development of data-driven (financial) models and simulations to better understand and predict healthcare trends and outcomes
2	National Digital Health Strategy - Phase II (in progress)	Implementation of NDHS recommendations.
3	National Health System Metrics (start early 2024)	Establishment of a national digital health dashboard based on previously defined healthcare KPI's/metrics
4	National Health System Standards	Develop guidelines for data standards, including ethical and transparent use of data
5	UHC Core Health Services (start December 2023)	Identification of core healthcare services to be in UHC package of benefits; review of the Enhanced Care Pilot.
6	Integrated Care Pathways – Phase II (further mapping and implementation)	Development of four additional Integrated Care Pathways and implementation of the previously mapped Care Pathways
7	Health Regulations	Formulation of legislation and policies to manage implementation of UHC
8	Healthcare Workforce Strategy	A plan that outlines the recruitment, training, and deployment of healthcare professionals to ensure a skilled and adequate healthcare workforce to meet the population's needs



1. UHC at a glance

Tentative timelines of the eight initiatives have been discussed and will be finalised soon, with first of which began in October 2023, with the remaining intended for early 2024.

5. Next steps for UHC



Several key milestones guide our work over the coming months





Define the core healthcare services to be included in the benefits package for all residents.



Understand the demand and cost to deliver core healthcare services.

Develop payment model options for the core care services and consider wider health system financing.



Financial analysis to baseline and then model options for Core Benefits Package.

Evaluate the economic impact of the options.



Recommend most suitable and sustainable option enabling delivery of the Core Benefits Package, ensuring costs meet resources (system and individual).



Adopt a phased approach to implementing Core Benefits Package starting with basic core benefits for all.
